This partial schedule of fees has been prepared and published in compliance with the Insurance Code of the State of California. Its purpose is to serve as an aid in determining charges for services regularly rendered.

The rates, fees and charges set forth in this Schedule are on file with the California Department of Insurance and are minimum charges only. Additional rates, fees and charges may be added when unusual risks are assumed or unusual services are performed in accordance with California Insurance Code Section 12401.8.

This partial schedule of fees applies to residential transactions.

The EAGLE® Protection Policy

An expanded title policy for owners and lenders on improved one-to-four family residences, including condominiums. It includes additional protection and is the best overall coverage available today.

▼ **COLUMN 1 - *Insurance amount.***

This is the amount of the Owner's Policy, usually the sales price. Round up to the next \$10,000 to determine the rate.

▼ **COLUMN 2 - *Eagle Owner's Policy.***

This rate applies to an expanded coverage owner's policy which includes coverage for certain future risks. This policy is also known as the CLTA/ALTA Homeowner's Policy. It is the best coverage available, and the default policy specified in the standard C.A.R. purchase contract. Ask your title representative for further details.

▼ **COLUMN 3 - *Standard Owner's Policy.***

This rate applies to certain residential resales if **1)** the property or buyer does not qualify for EAGLE coverage, **2)** the customer does not want the EAGLE® protection policy, or **3)** the customer does not want to pay the additional premium for the EAGLE® protection policy. If a Standard Owner's Policy is chosen, a waiver of EAGLE coverage must be signed acknowledging that the buyer is aware of the risks that are not covered under the Standard Owner's Policy. This rate is the same as our Basic Insurance Rate. An ALTA Owner's Policy with Western Regional Exceptions, ALTA Plain Language Owner's Policy or CLTA Standard Owner's Policy are some of the policies that can be issued as a Standard Owner's Policy.

▼ **COLUMN 4 - ALTA Extended Loan Policy issued concurrent with EAGLE or Standard Owner's Policy.**

This rate is based on the loan amount and applies when an Extended Loan Policy is issued concurrently with an EAGLE® protection or Standard Owner's Policy. Most institutional lenders require an ALTA Loan Policy. The Extended version, an ALTA Loan Policy issued without western regional exceptions, is most commonly required under FNMA and Freddie Mac guidelines.

▼ **COLUMN 5 - Refinance Rate.**

This rate applies to transactions where an ALTA Extended Loan Policy (ALTA Loan Policy without Regional Exceptions) is issued on improved one-to-four-family residential properties, where the loan proceeds are being used for any purpose other than financing of the acquisition of the property in a concurrent purchase transaction.

**The EAGLE Owner's Policy (CLTA/ALTA Homeowner's Policy of Title Insurance) is the default policy and specified in the C.A.R. contract.*
